Active in pro bono work, Kim serves as a conciliation court referee for the First Judicial District Court, and has received awards for her work in representing indigent clients in immigration and expungement matters.

- > Obtained early dismissal of loan originator in ResCap Liquidating Trust Litigation (Minnesota Federal District Court -- consolidated action of over 60 cases involving mortgage-backed securities).
- > In Minnesota State Court, represented trust company in litigation involving claims of first impression under the Tax Relief, Unemployment Insurance Reauthorization, and Job Creation Act of 2010 -- obtained requested Court ruling on declaratory relief sought.
- > Summary judgment in favor of Fortune 100 client binding Fortune 100 adversary to lease terms, finding adversary to be in breach of lease restrictions, and determining that client's claims were not barred by statute of limitations, laches, and waiver.
- > Represented corporate trustee of South Dakota dynasty trust through multi-jurisdictional dispute involving federal courts and state court, securing approval of fiduciary fees, preservation of South Dakota situs, and no liability for corporate trustee caught in the middle of a familial dispute.
